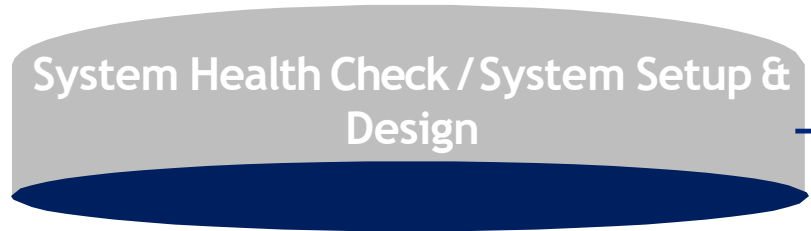

 - ✓ Upgrading the Technology Tools & Solutions.

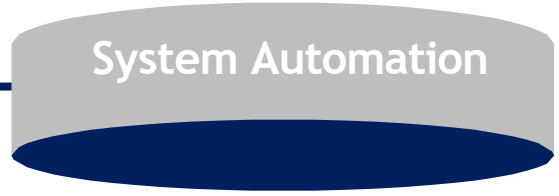

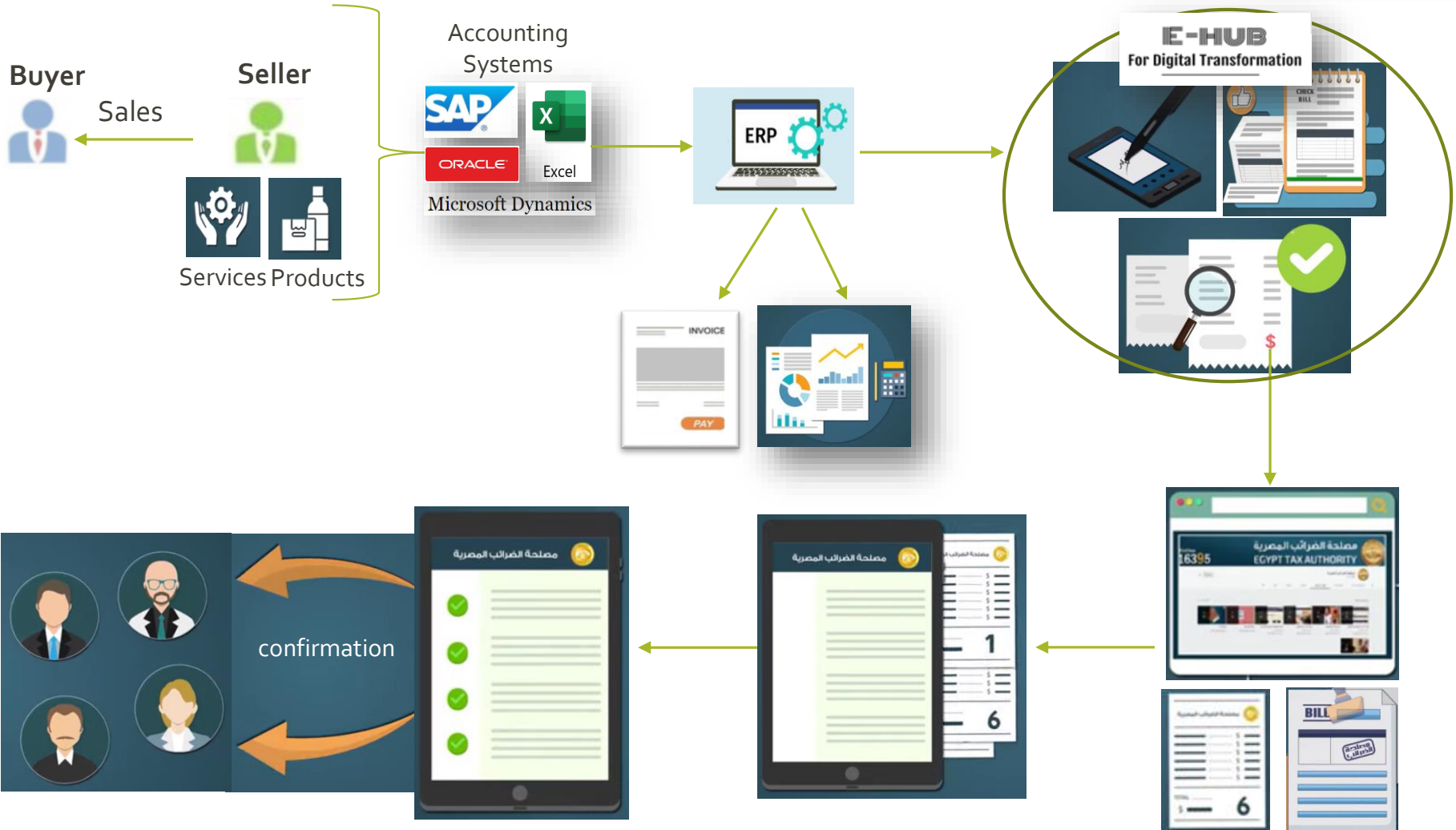
